



## **The BEST initiative: an opportunity to strengthen the conservation and sustainable use of biodiversity in the European overseas entities**

### **Context and background :**

The European Union comprise 34 Outermost Regions (ORs) and Overseas Countries and Territories (OCTs) located in 7 regions and 3 oceans : Caribbean, Indian Ocean, Pacific, Macaronesia, Polar and Sub-polar, Amazon and South Atlantic.

Those territories belong or are politically attached to six EU countries (Denmark, France, The Netherlands, Portugal, Spain, UK), even though they are in some cases geographically very distant from continental Europe.

Those entities are very rich in biodiversity and natural resources. They host a high number of endemic species and are home to several Key Biodiversity Areas (KBAs), globally important for the biodiversity worldwide.

This natural heritage is instrumental for the economic, social and cultural potential of the inhabitants of those entities. Serious threats are being faced by biodiversity there, such as the destruction of habitats, spreading of invasive alien species, or pollutions to the natural habitats. This, combined with their isolation and their insular nature (except for French Guyana), makes most of them very vulnerable, especially to the effects of climate change.

For these reasons it is vital for the European Union to ensure the conservation and a sustainable use of biodiversity and ecosystem services in these overseas entities. Due to their particular political status, EU Overseas do not rely today on a sustainable and long-lasting funding european scheme to protect their biodiversity and natural resources on the long-term.

The BEST initiative – which stands for Voluntary scheme for Biodiversity and Ecosystem Services in Territories of EU Overseas – has been launched in 2010 by the European Parliament to promote conservation and sustainable use of biodiversity and ecosystem services in EU ORs and OCTs. The first two years of the BEST preparatory action, BEST 2011 and BEST 2012, have been implemented through two open calls and have attracted 84 eligible proposals – with a total of 16 projects financed in the end plus 2 reserve list projects funded through the Agence française de Développement given their interest.

**The project : a network of regional hubs to identify the priorities for investment, and inform and train local stakeholders**

The number, the high-level of demand and the quality of the projects' proposals have clearly demonstrated the need for funding directed to projects aimed at protecting EU Overseas biodiversity.

It was therefore decided that the funds available for the third and last year of the BEST preparatory action would be invested in ensuring the sustainability of the BEST scheme.

This actual third and last year of the BEST Preparatory Action was implemented through an open call for tender launched in 2013. The successful tenderer is an international consortium of 10 partners led by IUCN, which mission is to carry out this work in all the regions of the EU overseas in close conjunction with key institutions involved in these topics, both at the local and national levels.

In the Caribbean Region, the SPAW RAC (Regional Activity Center for Specially Protected Areas and Wildlife) in partnership with the Natural Reserve of St Martin will be in charge of the coordination of the Caribbean regional hub and of the development of the Caribbean ecosystem profiles for the 15 European overseas entities in close partnership with the existing networks and stakeholders.

There are 15 EU overseas entities in The Caribbean

- UK entities: Anguilla, British Virgin Islands, Cayman Islands, Turks and Caicos, Montserrat
- Dutch entities : Aruba, Bonaire, Curacao , Saba , Sint Eustatius, Sint Maarten
- French entities : Saint Martin, Martinique , Guadeloupe, Saint Barthelemy



## **The objective: a 5-year action plan and priority areas for biodiversity conservation identified**

The expected outcomes of the BEST initiatives are the following :

- setting up a Caribbean hub for the BEST initiative that can centralise, exchange and build on existing or future projects on biodiversity conservation and sustainable use of ecosystem services
- developing a regional ecosystem profile for the Caribbean based on collected scientific data and on consultation with local or regional stakeholders and experts in order to identify key biodiversity areas
- contributing to the Caribbean BEST strategy where priority of actions and assessment of current investment in biodiversity will be identified in order to define niche for investment and establish a 5 years action plan to submit to the European Commission.

## **Timeframe : a project over four years with several steps**

The first two years will be dedicated to the development of the ecosystem profiles, with several series of exchanges, both bilaterally and collectively, with local stakeholders.

Then the investment strategy for the Caribbean, and after the general BEST investment strategy, will be determined on this basis.

The last two years of the project will be dedicated to identifying donors that can contribute to fund BEST in addition to European funds, and to networking between the partners of the overseas entities, and those potential donors.

## **The BEST Team in the Caribbean**

Director of the SPAW-RAC Anne Fontaine is in charge of the BEST Caribbean team and Romain Renoux, Officer in charge of regional cooperation with the Natural Reserve of St Martin, is the Caribbean hub coordinator. Amandine Vaslet will be in charge of the elaboration of the ecosystem profile.
